MINUTES

FDACS REPORT

WARREN - not in attendance. No report.

NRCS REPORT

DIAZ-ALVAREZ – reported 44 applications for FY 2023 have been received for EQUIP Classic and 34 applications have been received for Emergency EQUIP. ALBARRAN reported the payment range for the Conservation Stewardship Program (CSP). HERNANDEZ reported that the CSP is available to eligible producers based on adopting new conservation activities and the application deadline is end of February. ALBARRAN reported that workshops about NRCS with the help of HSWCD will be scheduled in the near future. NRCS office in Plant City is in the process of hiring a new Agricultural Engineer.

McCULLOUGH requested a review of the description of the new technical position proposed last meeting. Quarter 1, 2024 is the goal to have this position ready to go. HERNANDEZ requested the contact person for this ongoing issue be Hillary Barnhart at NRCS in HERNANDEZ's office.

HERNANDEZ clarified that a farm must be registered through FSA in order to get funds from NRCS.

SWFWMD

STEVENS and LaRICHE - nothing to report at this time.

GRINER - reported on a presentation about silica (frost freeze protection) to be used on citrus and other fruits (blueberries) with success. Potential of saving ½ of water used in frost/freeze/heat stress protection. Presentation to be shared with NRCS and HSWCD. Encouraged participation in mini-farms and farms programs.

AGRIBUSINESS REPORT

BOLLIN - not in attendance. No report.

GILL - reported he received an email from FDACS about HSWCD Cost Share being out of compliance with contracts and invoices that potentially can incur penalties. PROCTOR reported he received information about this issue right before the meeting began. TOMPKINS reported she had not received any information about this issue except the email from GILL. She clarified that these items are on today's agenda. MORRIS moved to request FDACS freeze the penalties as of today in order for the board to meet about these documents received within 10 days. Update on State Legislation SB 1078: TOMPKINS continues to work with Hillsborough Legislative Delegation members to address unequal geographic districts. Danny Alvarez, member of the FL House of Representatives, has been asked to sponsor a Local Bill to address this deficiency.

Update on Legislation that addresses hostile countries purchasing agricultural land and land near military bases in Florida: HSWCD is following this legislation and this will be reviewed at Farm Bureau Day at the Capitol on March 8, 2023.

February 1, 2023 Legislative Delegation meeting at USF was attended by PROCTOR, MORRIS, and TOMPKINS.

Regular Board meeting on March 22, 2023 to be rescheduled. MORRIS moved to change the date and time of the regular board meeting to March 29, 2023 at 3 pm at FSGA. YOUNG seconded. Motion passed, with PROCTOR providing comments.

4-H U-pick at Fancy Farms on February 18, 2023 raised \$21,000 for the 4-H program..

Update on joint grant from USDA with HSWCD partnering with City of Tampa, and Coalition of Community Gardens. Final paperwork to be signed soon.

Budget request for 2023 - 2024 is being worked on.
